In accordance with the provisions of Articles 7 and 8 of Legislative Decree no. 196, The concerned party has the right:

1. knowing the existence of personal data that is relevant to you, which must be made available to you in intelligible form;
2. to know the origin of the data concerning you;
3. to know the purposes and the methods of treatment;
4. to know the logic applied when processing by electronic means;
5. to know the details of the holder and those responsible for the treatment;
6. to know the subjects or categories of subjects to whom the personal data can be communicated;
7. the updating, rectification or integration of personal data concerning you;
8. for the deletion, transformation into anonymous form or the blocking of the personal data that concern you, whose treatment was not properly authorized;

9. to oppose, for legitimate reasons, the processing of data even though relevant to the purpose of the collection;
10. to oppose the processing of data intended for the purpose of sending advertising material or for the purpose of commercial information.
